- **Match Procedures - New Referees especially to note;**
  - Home club to confirm by Tuesday. Failure to do so by Wednesday please contact Mike Parr.
  - Match day. Arrive at ground no later than 30 minutes before kick off.
  - Match report to be given to you in dressing room before the start of the game, completed by both teams including the substitutes.
  - After game you are to fill in the score and record any sending off's or cautions in the appropriate boxes on the bottom of the form.
  - The home club to collect form and pay you in dressing room, normally within 15/20 minutes after the final whistle.
  - All misconduct to be reported to BCFA within 2 days.

Referee fees this season are £29 & £20 an assistant. Could I please remind clubs that the Match Form must be completed & handed to or placed in the referee's room BEFORE the match. Furthermore referees must be paid their fee ASAP after the match and not be expected "to hunt the club down" for their fee!!
